

ORDINANCE NO. 6-24-14 (B)

ORDINANCE PROHIBITING ALL TERRAIN VEHICLES (ATVs) AND ALL PURPOSE VEHICLES (APVs) FROM USING THE GRASSY AREAS IN VILLAGE PARKS, AND DECLARING AN EMERGENCY.

WHEREAS, ORC Chapter 4519 regulates the licensing, use, operation and registration of certain “special vehicles,”as defined therein; and

WHEREAS, the Village of Jacksonville does not wish to impede or further regulate such special vehicles within its jurisdiction, except to limit use of such vehicles in Village parks.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO AS FOLLOWS:

1. No special or additional regulations as to licensing, regulation, operation, or use of All Terrain Vehicles (ATVs) or All Purpose Vehicles (APVs), shall be imposed by the Village of Jacksonville.
2. Jacksonville Village Council believes that the Regulations and requirements set forth under state law, in Ohio Revised Code Chapter 4519, are sufficient.
3. However, Council believes that the quiet enjoyment of its Village Parks requires the prohibition of such vehicles, inside the Village Park perimeters on the grassy areas.
4. Any one violating this Ordinance shall be subject to a fine not to exceed \$150.00 for each occurrence.
5. It is found and determined that all formal actions of Council relating to the passage of this Ordinance were conducted in open meetings of the Village Council and that all deliberations of Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Sec. 121.22 of the Ohio Revised Code.
6. This Ordinance is being passed as an emergency measure to take effect immediately, pursuant to Ohio Rev. Code Sec. 731.30 because it is necessary for the immediate preservation of the health, safety and welfare of the Citizens of the Village.
7. This Ordinance shall become effective the earliest date allowed by law.
