

RESOLUTION NO. 11242015 (A)

**TAX CERTIFICATION RESOLUTION
(SUBMITTED BEFORE TAX LEVY RESOLUTION)**

WHEREAS, the Village of Jacksonville is in need of additional Current Operating Expenses for the subdivision, pursuant to R.C. 5705.19(A); and

WHEREAS an **ADDITIONAL TAX LEVY** for such purpose beginning with the 2016 tax year, will need to be approved by the voters to continue the operation of the subdivision.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO AS FOLLOWS:

1. The Village of Jacksonville requests that the County Auditor certify to the Village Clerk, Treasurer, or Fiscal Officer, the total current tax valuation of the subdivision, and the dollar amount of additional revenue that will be generated by the placement of a 3.2 mill replacement current expense levy for Tax Year 2016, for a period of five (5) years to begin collection in calendar year 2017.
2. This Resolution is being passed as an emergency measure under suspension of the rules, to take effect immediately, pursuant to Ohio R.C. § 731.30 because it is necessary for the preservation of the health, safety and welfare of the Citizens of Jacksonville, and because immediate construction and improvements by the adjoining property owner are scheduled to begin;
3. All deliberations resulting in the passage of this resolution were conducted in open meetings of Council, and that all deliberations of Council that resulted in such action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
4. Publication of this Resolution shall be made by posting a copy of the same in at least five (5) locations within the Village; and
5. This Resolution shall become effective immediately, the same being the earliest date allowed by law.




WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Village of Jacksonville, Athens County, Ohio; therefore be it

RESOLVED by the Council of the Village of Jacksonville, Athens County, Ohio, two thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Jacksonville, for the purpose of current operating expenses R.C. 5705.19(A) at a rate not exceeding 3.2 mills for each one dollar of valuation, which amounts to \$ 0.32 per \$100 dollars of valuation for¹ five (5) years, General Fund - Current Operating Expenses - Replacement, commencing in 2016, first due in 2017.

RESOLVED that the Clerk of this Village is hereby directed to certify a copy of this Resolution to the Board of Elections Athens, County, Ohio², and notify said Board of Elections to cause notice of election on the question of levying said tax to be given on the question of levying said






