RESOLUTION NO. 12152015C

RESOLUTION APPROPRIATING MONEY FOR YEAR 2016 AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Jacksonville has determined that it needs to appropriate additional money to meet expenses coming due in 2016;

WHEREAS, this money needs to be appropriated quickly, in order to avoid delinquent payments, and for the health safety and welfare of the Citizens of the Village of Jacksonville;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO AS

FOLLOWS:

1. The sum of eight thousand five hundred and ninety one dollars (\$8,591.00) from the General Fund, account ending in 1000.
2. The sum of two thousand, eight hundred and seventeen (\$2,817.00) from the Street Construction Fund, account ending in 2011.
3. The sum of thirty-eight dollars (\$38) from the State Highway Fund, account ending in 2021.
4. The sum of thirteen thousand, one hundred and eighty-nine dollars (\$13,189) from the Fire Fund, account ending in 2901.
5. The sum of four thousand, five hundred and sixty-nine dollars (\$4,569) from the Street Light Fund, account ending in 2902.
6. The sum of thirty-four thousand, two hundred and sixty-four dollars (\$34,264) from the Water Operating Fund, account ending in 5101.
7. It is found and determined that all formal actions of Council concerning and relating to the passage of this Resolution were conducted in open meetings of Council, and that all deliberations of Council that resulted in formal action were in meetings open to the public, in compliance with all

legal requirements including Sec. 121.22 of the Ohio Revised Code;

8. This Resolution is being passed as an emergency measure under suspension of the rules, to take effect immediately, pursuant to Ohio Rev. Code Sec. 731.30 because it is necessary for the immediate preservation of the health, safety and welfare of the Citizens of Jacksonville;

9. Publication of this Resolution shall be made by posting a copy of the same in at least 5 locations within the Village; and


10. This Resolution shall become effective the earliest date allowed by law.


