

**ORDINANCE NO. 12212015A**

**ORDINANCE APPROPRIATING MONEY FROM FIRE FUND AND WATER FUND APPROPRIATING MONEY THROUGH THE REST OF THE YEAR, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Jacksonville has determined that it needs to appropriate additional money from the fire and water funds, in order to meet current expenses in 2015;

**WHEREAS**, this money needs to be appropriated quickly, in order to avoid delinquent payments, and for the health safety and welfare of the Citizens of the Village of Jacksonville;

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO AS FOLLOWS:**


1. The sum of nineteen thousand dollars (\$19,000) is hereby appropriated from the Fire Protection Fund.
2. The sum of six thousand dollars (\$6,000) is hereby appropriated from the Water Operating Fund.
3. It is found and determined that all formal actions of Council concerning and relating to the passage of this Ordinance were conducted in open meetings of Council, and that all deliberations of Council that resulted in formal action were in meetings open to the public, in compliance with all legal requirements including Sec. 121.22 of the Ohio Revised Code;
4. This Ordinance is being passed as an emergency measure under suspension of the rules, to take effect immediately, pursuant to Ohio Rev. Code Sec. 731.30 because it is necessary for the immediate preservation of the health, safety and welfare of the Citizens of Jacksonville;





6. This Ordinance shall become effective the earliest date allowed by law.


