

RESOLUTION NO. 2021-6

A RESOLUTION AUTHORIZING THE MAYOR TO HIRE A VILLAGE ADMINISTRATOR AND VILLAGE EMPLOYEE, AND DELCARING AN EMERGENCY.

WHEREAS, Members of Council recognize the immediate need to hire a Village Administrator to perform maintenance, repair and service work for the Village Water Department, Streets, Parks, Buildings and the general upkeep necessary to provide for the health, safety and services necessary for Village residents;

WHEREAS, Members of Council also recognize that a new Village Administrator will not have the capacity to perform all work that is necessary at this time and that the Village would be well served by the hiring of an additional Village Employee to assist the Village Administrator;

WHEREAS, the State Auditor is currently reviewing Village finances and will provide a recommendation on whether hiring a Village Employee is financially prudent;

WHEREAS, if it is determined that the Village is in a fiscal position to do so, the Mayor may hire a Village Employee who was among the unsuccessful applicants for the Village Administrator position; and

WHEREAS, the Village Council declares this an emergency as there is an urgent and immediate need to rectify this situation in order to ensure appropriate staffing to maintain essential Village operations, protect lives, homes, and property, and to ensure the needs of those who reside and work in the Village of Jacksonville;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO:

That the Mayor of Jacksonville is authorized to:

- 1) Hire a Village Administrator at his earliest opportunity; and
- 2) If a review by the State Auditor's office concludes that it there are adequate resources to do so, the Mayor is also authorized to negotiate the pay and hire a Village Employee at his discretion.
