

## RESOLUTION NO. 2021-10

### A RESOLUTION SETTING WAGES FOR EMPLOYEES NOT OTHERWISE COVERED BY CONTRACTS AND DELCARING AN EMERGENCY.

WHEREAS, the Village of Jacksonville, Ohio deems it necessary to provide for the rate of pay for the employees and elected officials who are not otherwise covered by contracts:

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of New Lexington, Ohio as follows:

**Section 1:** That effective the pay period beginning June 20, 2021 the following employees shall perform the duties required of their respective position for the base pay rate as follows:


POSITION	BASE	RATE
Mayor (part time)	\$ 175.00	Per Month
Council (part time)	\$ 20.00	Per Month
Village Solicitor (part time)	\$ 600.00	Per Month
Village Administrator (full time)	\$ 15.00	Per Hour
Water Operator (full time)	\$ 19.00	Per Hour
Fiscal Officer (part time)	\$ 450.00	Per Month
Water Clerk (part time)	\$ 300.00	Per Month
Custodian (part time)	\$ 160.00	Bi-weekly


**Section 2:** That any and all ordinances and resolutions inconsistent with the resolution are hereby repealed to the extent that they inconsistent with this resolution.
