

## RESOLUTION 2021-11

### A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO EXECUTE CONTRACTS FOR EMPLOYEE INSURANCE BENEFITS WITH ANTHEM BLUE CROSS BLUE SHIELD, DELTA DENTAL, AND VISION SERVICE PLAN THROUGH OHIO INSURANCE SERVICES AND DECLARING AN EMERGENCY

WHEREAS, the Village of Jacksonville, Ohio does hereby agree to obtain employee health insurance benefits with Anthem Blue Cross Blue Shield, dental insurance benefits with Delta Dental, and vision insurance with Vision Service Plan effective August 1, 2021 through December 31, 2021 at the benefit levels and cost structure as presented in the proposal.


NOW THEREFORE BE IT RESOLVED by the Council of the Village of Jacksonville, Ohio:


**Section 1:** That the Village Fiscal Officer be and is hereby authorized to act as the representative for the Village of Jacksonville and execute any paperwork, proposals and/or documents with Anthem Blue Cross Blue Shield, Delta Dental, Vision Service Plan and/or Ohio Insurance Services.

**Section 2:** That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the Village of Jacksonville and that this resolution shall take effect and be in full force from and after the earliest period allowed by law.
