

RESOLUTION 2022-1

A RESOLUTION ESTABLISHING A BLANKET PURCHASE ORDER AMOUNT LIMIT AS REQUIRED BY OHIO REVISED CODE 5705.41(D)(3) AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code 5705.41(D)(3) allows political subdivisions to use blanket purchase orders for payment of lawfully appropriated goods and services of the subdivision in place of regular purchase orders; and

WHEREAS, the Village of Jacksonville currently does not have a maximum amount allowed for blanket purchase orders established; and

WHEREAS, the Administration has recommended a blanket purchase order amount limit not to exceed \$30,000 unless authorized by Ordinance or Resolution of Village Council; and

WHEREAS, the Village of Jacksonville desires to establish a blanket purchase order amount limit related to the purchase order policy.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Jacksonville, Athens County, Ohio, that:

SECTION 1: That Council hereby establishes a blanket purchase order amount limit not to exceed \$30,000 unless a purchase for a higher amount has been approved by Ordinance or Resolution of Council in accordance with Ohio Revised Code 5705.41(D)(3).

SECTION 2: That a purchase order issued pursuant to any Council Ordinance or Resolution shall not exceed the amount stipulated in the Ordinance or Resolution, or when not specified, shall not exceed the appropriation or legal level of control established by Council.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees on or after December 2, 1975, that resulted in formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Resolution is declared to be an emergency measure necessary to preserve the health, safety and welfare of the citizens of the Village of Jacksonville, Ohio and shall be effective upon passage or at the earliest date allowed by law.
