

# Resolution 2022-4

## TAX CERTIFICATION RESOLUTION (SUBMITTED BEFORE TAX LEVY RESOLUTION) AND DECLARING AN EMERGENCY

**WHEREAS** the Village of Jacksonville has a tax levy for the purpose of **Current Expense** of the Village of Jacksonville, pursuant to Ohio Revised Code Section 5705.19(A); and

**WHEREAS**, this levy will expire at the end of 2021, and will need to be **renewed** to continue the operation of the Village of Jacksonville.

**WHEREAS**, The Village of Jacksonville desires to place such a levy before the voters at the primary election to be held on May 3, 2022.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO AS FOLLOWS:**

**Section 1:** The Village of Jacksonville requests that the County Auditor certify to the Village Clerk, Treasurer, or Fiscal Officer, the total current tax valuation of the Village of Jacksonville, and the dollar amount of revenue that will be generated by the **renewal** of this **5.30 mil Current Expense Levy** for Tax Year 2022, for a period of five (5) years to begin collection in calendar year 2023.

**Section 2:** This Resolution is being passed as an emergency measure under suspension of the rules, to take effect immediately, pursuant to Ohio Revised Code Section 731.30 because it is necessary for the preservation of the health, safety and welfare of the citizens of Jacksonville.

**Section 3:** All deliberations resulting in the passage of this Resolution were conducted in open meetings of Council, and all deliberations of Council that resulted in such action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**Section 4:** Publication of this Resolution shall be made by posting a copy of the same in at least five (5) locations within the Village; and

**Section 5:** This Resolution shall become effective the earliest date provided by law.
