ORDINANCE NO. 2018-07

ORDINANCE ACCEPTING THE FEMA ASSISTANCE TO FIREFIGHTERS GRANT AND AUTHORIZING THE VOLUNTEER FIRE DEPARTMENT TO CONTRACT FOR GRANT SERVICES AND DECLARING AN EMERGENCY

WHEREAS, the Village of Jacksonville Volunteer Fire Department has successfully applied for a \$94,500.00 grant from the Federal Emergency Management Agency (FEMA) for Self-Contained Breathing Apparatus in order to replace obsolete equipment; and

WHEREAS, FEMA has awarded the Village of Jacksonville Grant #
EMW-2017-FO-02336 under the FEMA Assistance to Firefighters Grant program.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF JACKSONVILLE, ATHENS COUNTY, OHIO AS FOLLOWS:

- 1. The Village accepts FEMA Grant # EMW-2017-FO-02336 in the amount of \$94,500.00.
- 2. The Village authorizes the Village Volunteer Fire Department to contract with Mr. Mikey Smith to manage this grant.
- 3. The Village commends the Jacksonville Volunteer Fire Department for its successful application.
- 4. It is found and determined that all formal actions of Council concerning and relating to the passage of this Ordinance were conducted in open meetings of Council, and that all deliberations of Council that resulted in formal action were in meetings open to the public, in compliance with all legal requirements including Sec. 121.22 of the Ohio Revised Code;
- 5. This Ordinance is being passed as an emergency measure under suspension of the rules, to take effect immediately, pursuant to Ohio Rev. Code Sec. 731.30 because it is necessary for the immediate preservation of the health, safety and welfare of the Citizens of Jacksonville;
- 6. Publication of this Ordinance shall be made by posting a copy of the same in at least 5 locations within the Village; and
- 7. This Ordinance shall become effective the earliest date allowed by law.
