ORDINANCE NO. 2018-08

ORDINANCE ENTERING INTO AN EMPLOYMENT AGREEMENT WITH RON RILEY TO PROVIDE SERVICES TO THE VILLAGE WATER DEPARTMENT, AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Jacksonville is in need of a qualified individual to work in the Jacksonville Water Department, to take daily samples, prepare monthly reports for the Ohio Environmental Protection Agency (OEPA), and to perform other duties as required by the OEPA; and

WHEREAS, Village Council has voted to offer employment to Mr. Ron Riley, who possesses the qualifications to take on such responsibilities as the Village Water Operator.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF JACKSONVILLE, ATHENS COUNTY, OHIO AS FOLLOWS:

- 1. The Mayor is hereby authorized to sign the attached Employment Agreement with Ron Riley on behalf of the Village of Jacksonville, upon the terms and conditions stated therein.
- 2. It is found and determined that all formal actions of Council concerning and relating to the passage of this Ordinance were conducted in open meetings of Council, and that all deliberations of Council that resulted in formal action were in meetings open to the public, in compliance with all legal requirements including Sec. 121.22 of the Ohio Revised Code;
- 3. This Ordinance is being passed as an emergency measure under suspension of the rules, to take effect immediately, pursuant to Ohio Rev. Code Sec. 731.30 because it is necessary for the immediate preservation of the health, safety and welfare of the Citizens of Jacksonville;
- 4. Publication of this Ordinance shall be made by posting a copy of the same in at least 5 locations within the Village; and
- 5. This Ordinance shall become effective the earliest date allowed by law.
