

Resolution 2017-05

A Resolution approving the proposed Hall and Kitchen Rental Fees as amended by Village Council at the March 21, 2017 Council meeting. *retroactively effective 2/22/17.*
And declaring an emergency.

WHEREAS, the Village desires to make these fees uniform and known to the public; and

WHEREAS, Village Council desires to change the amounts previously approved in Resolution 2017-01 and replace it with Resolution 2017-05.

NOW, THEREFORE, BE IT RESOLVED THAT THE VILLAGE OF JACKSONVILLE APPROVES THE HALL AND KITCHEN RENTAL FEES INCLUDED IN THE ATTACHED "HALL AND KITCHEN RENTAL FEES" AGREED UPON BY THE VILLAGE COUNCIL AT THE MARCH 21, 2017 COUNCIL MEETING.

Village of Jacksonville Hall and Kitchen Rental Fees

1. Hall rental is $\$75.00 + \25.00 refundable deposit = $\$100.00$ due when reservation is made. The person making the reservation is required to be at the event during its entirety.
2. Kitchen rental is an additional $\$25.00 + \75.00 hall rental + $\$25.00$ refundable deposit = $\$125.00$ due when reservation is made. The person making the reservation is required to be at the event during its entirety.
3. The rental fee for funerals or meal after a funeral will be free. A $\$25.00$ refundable deposit due when the reservation is made. The person making the reservation is required to be at the event during its entirety.
4. The rental fee for any active firemen or women is $\$25.00$ hall rental + $\$25.00$ refundable deposit = $\$50.00$ due when the reservation is made. Kitchen rental is an additional $\$25.00 + \25.00 hall rental + $\$25.00$ refundable deposit = $\$75.00$ due when the reservation is made. The person making the reservation is required to be at the event during its entirety.
5. The rental fee for any current Mayor, Council members or Village employees is $\$25.00$ hall rental + $\$25.00$ refundable deposit = $\$50.00$ is due when the reservation is

made. Kitchen rental is an additional \$25.00 + \$25.00 hall rental + \$25.00 refundable deposit = \$75.00 is due when the reservation is made. The person making the reservation is required to be at the event during its entirety.

6. The rental fee for Civic organizations, School functions, Fundraisers and Churches. Hall rental \$50.00 + \$25.00 refundable deposit = \$75.00 due when the reservation is made. Kitchen rental is an additional \$25.00 + \$50.00 hall rental + \$25.00 refundable deposit = \$100.00 due when the reservation is made. The person making the reservation is required to be at the event during its entirety.

7. The Old Settlers Reunion hall rental fee and kitchen is free up to ten (10) events per year. After ten (10) events the fee will be same as in section 6. A \$25.00 refundable deposit due when the reservation is made. The person making the reservation is required to be at the event during its entirety.

8. All reservations are on a first come first serve basis.

9. The hall and kitchen must be cleaned immediately after your event.

10. Additional rules. No animals are permitted in the building except service animals. No smoking in the building. Alcohol is permitted in limited quantity. Do not block any doors to the fire department inside and outside. Maximum capacity is **120. Any and All damages are**

responsible by the person making the reservation.
