

**RESOLUTION NO. 2017-30**

**A RESOLUTION CERTIFYING THE PERMANENT REMOVAL OF TWO FIRE DEPARTMENT VEHICLES THAT ARE DEEMED OBSOLETE AND UNSAFE.**

*AND DECLARING AN EMERGENCY*

**WHEREAS**, in order to be awarded a FEMA grant to replace obsolete and unsafe vehicles (1984 Ford F-700 and 1983 Ford F-800) the Village must certify the vehicles that are to be replaced will be permanently removed from emergency service response of the Village;

**WHEREAS**, permanently removed from emergency service response means the recipient cannot use the vehicle being replaced for any emergency service response, nor can the recipient sell or otherwise transfer title to any individual or emergency service response organization that will use the unsafe vehicle(s) for emergency service response;


**WHEREAS**, a recipient who certifies it will remove an unsafe vehicle from service but then sells/transfers the unsafe vehicle to another emergency service response organization, or otherwise does not remove the unsafe vehicle from emergency service response, is considered to be in violation of the FEMA grant agreement; and

**WHEREAS**, acceptable dispositions (donation or sale) of unsafe vehicles include, but are not limited to: a training facility with NO emergency response off the training grounds, farm use, construction or nursery use, sale to a non-emergency service response entity for refurbishment, scrap metal, salvage, or foreign donation.

**NOW, THEREFORE, BE IT RESOLVED THAT THE VILLAGE OF JACKSONVILLE HEREBY AUTHORIZES AND CERTIFIES THAT THE VILLAGE WILL REMOVE THE TWO FIRE DEPARTMENT VEHICLES DEEMED OBSOLETE AND UNSAFE THAT ARE BEING REPLACED THROUGH THE SAID FEMA GRANT.**
