

Resolution No. 2024-13

**A RESOLUTION TO ADOPT THE SOLID WASTE MANAGEMENT PLAN
FOR THE ATHENS-HOCKING SOLID WASTE DISTRICT
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Jacksonville in Athens County is located within the Athens-Hocking Solid Waste District.

WHEREAS, the Athens-Hocking Solid Waste District Policy Committee prepared and adopted a final draft of the Solid Waste Management Plan in accordance with Ohio Revised Code Sections 3734.53 3734.54 and 3734.55.

WHEREAS, the Athens-Hocking Solid Waste District has provided access to a copy of the Adopted Solid Waste Management Plan for ratification to each of the legislative authorities of the District.

WHEREAS, the Village of Jacksonville must decide whether it approves of said Solid Waste Management Plan within ninety days of receipt of the Final Draft Plan.

NOW, Therefore, Be It Resolved by Council of the Village of Jacksonville in Athens County:

1. The Village of Jacksonville either (please indicate):

a. approves the District Solid Waste Management Plan; or

b. disapproves the District Solid Waste Management Plan

3. That it is found and determined that all formal actions of the Council concerning and relating to the passage of this resolution were adopted in an open meeting of the Village

of Jacksonville and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Sections 121.22 of the Ohio Revised Code.


