

Village of Jacksonville Special Council Meeting
January 13, 2022
3:00 PM

The Village of Jacksonville met in special session with Acting Mayor Butch Chapman presiding to appoint members to the Jacksonville Volunteer Fire Department and to vote for legislation regarding blanket purchase orders, water rules and regulations and Auditor's Certificates for levies. The meeting was called to order at 3:31P. Council members present were Butch Chapman, Jay Chapman, Clinton Augustine, and Gary Simons. Fiscal Officer Heather Rockwell and Solicitor Andy Grillo were also present. Councilpersons Angela Strock and Rachel Gratz were absent.

Councilperson Butch Chapman made a motion to appoint Gary Simons to a vacant Council seat that opened on December 31, 2021. Seconded by Jay Chapman. All Council voted "yes". Motion carried. Solicitor Grillo swore in Councilperson Simons who accepted the vacant Council seat.

Councilperson Butch Chapman made a motion to appoint DJ Henry, Brett Downs, Don Rodgers, Floyd Conkey, Marvin Nichols, Brad Lowry, Jamie Irwin, Butch Chapman, Kenny Shank, Mike Carsey Sr., Hunter Shonborn, Caitlyn Hall, Matt Fisher, Brooks Faires, Mike Carsey Jr. and Colton Kline to the Jacksonville Volunteer Fire Department. Seconded by Councilperson Jay Chapman. All Council voted "yes". Motion carried.

Councilperson Butch Chapman made a motion to suspend the rules and read by title only Resolution 2022-1 declaring an emergency. Seconded by Councilperson Augustine. All Council voted "yes". Motion carried. Resolution 2022-1: A Resolution Establishing a Blanket Purchase Order Amount Limit as Required by Ohio Revised Code 5705.41(D)(3) and Declaring an Emergency. Councilperson Butch Chapman made a motion to adopt Resolution 2022-1 as read. Seconded by Councilperson Jay Chapman. All Council voted "yes". Motion carried.
