

RESOLUTION NO. 2023-10

A RESOLUTION AUTHORIZING THE FIRE CHIEF TO SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO DEPARTMENT OF COMMERCE 2023 FIRE DEPARTMENT INDIVIDUAL EQUIPMENT GRANT, EXECUTE ALL AGREEMENTS IF AWARDED AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Department of Commerce is accepting applications for the 2023 Fire Department Individual Equipment Grant (Grant) through the Division of State Fire Marshal (SFM);

WHEREAS, it is the Jacksonville Volunteer Fire Department's desire to apply for the Grant to purchase equipment which may include personal protective clothing, SCBA, communications and other miscellaneous equipment as allowed by the Grant; and

WHEREAS, if the Village is awarded the Grant, then the Village of Jacksonville will be required to appropriate and expend up to \$15,000.00 from the Fire Fund for the purchase of the equipment by separate Ordinance at a later date;


WHEREAS, if the Village of Jacksonville is awarded the Grant, then the Fire Chief will submit all items to Ohio Department of Commerce Division of State Fire Marshal to receive funds up to \$15,000. No matching funds are required for this Grant.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO:

That the Fire Chief of the Village of Jacksonville is authorized by Village Council to prepare and submit an application to Ohio Department of Commerce Division of State Fire Marshal, for the 2023 Fire Department Individual and Joint Equipment Grant up to \$15,000.00. If awarded, the Fire Chief is authorized to execute the necessary agreements with Ohio Department of Commerce Division of State Fire Marshal and submit documentation as required in accordance with the grant agreement.
