

RESOLUTION NO. 2023-11

A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO SUBMIT AN APPLICATION TO PARTICIPATE IN THE SPRING 2023 ROCKY COMMUNITY IMPROVEMENT FUND GRANT, EXECUTE ALL AGREEMENTS IF AWARDED AND DECLARING AN EMERGENCY.

WHEREAS, the Rocky Community Improvement Fund is accepting applications for the Spring 2023 Rocky Community Improvement Fund (RCIF) Grant (Grant) through the Athens County Foundation;

WHEREAS, it is the Village of Jacksonville's desire to apply for assistance with sidewalk improvements to improve senior mobility, handicap accessibility and walkability in the Village as allowed by the Grant; and

WHEREAS, if the Village of Jacksonville is awarded the Grant, then the Village will be required to appropriate and expend up to \$10,000.00 from the American Rescue Plan Act Fund for the project by separate Ordinance at a later date.

WHEREAS, if the Village of Jacksonville is awarded the Grant, then the Fiscal Officer will submit all items to RCIF to receive funds up to \$10,000. No matching funds are required for this Grant.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO:

That the Fiscal Officer of the Village of Jacksonville is authorized by Village Council to prepare and submit an application to Rocky Community Improvement Fund for the Spring 2023 Grant up to \$10,000.00. If awarded, the Fiscal Officer is authorized to execute the necessary agreements with RCIF and/or the Athens County Foundation and submit documentation as required in accordance with the grant agreement.
