

## RESOLUTION NO. 2023-17

### A RESOLUTION SETTING WAGES FOR EMPLOYEES NOT OTHERWISE COVERED BY CONTRACTS AND DECLARING AN EMERGENCY.

**WHEREAS**, the Village of Jacksonville, Ohio deems it necessary to provide for the rate of pay for the employees and elected officials who are not otherwise covered by contracts:

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Jacksonville, Ohio as follows:

**Section 1:** That effective the pay period beginning April 23, 2023 the following employees shall perform the duties required of their respective position for the base pay rate as follows:

POSITION	BASE	RATE
Mayor (part time)	\$ 175.00	Per Month
Council (part time)	\$ 20.00	Per Month
Village Solicitor (part time)	\$ 600.00	Per Month
Village Administrator (full time)	\$ 15.40	Per Hour
Water Operator (full time)	\$ 19.40	Per Hour
Fiscal Officer/Water Clerk (full time)	\$ 20.00	Per Hour
Custodian (part time)	\$ 160.00	Bi-weekly

**Section 2:** That any and all ordinances and resolutions inconsistent with the resolution are hereby repealed to the extent that they inconsistent with this resolution.

**Section 3:** This Resolution is being passed as an emergency measure because the immediate passage of the Resolution is necessary due to an employee insurance renewal effective May 1, 2023 and that this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety of the Village of Jacksonville.
