

RESOLUTION NO. 2023-8

A RESOLUTION AUTHORIZING THE FIRE CHIEF TO SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO DEPARTMENT OF NATURAL RESOURCES 2023 VOLUNTEER FIRE ASSISTANCE GRANT, EXECUTE ALL AGREEMENTS IF AWARDED AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Department of Natural Resources (ODNR) is accepting applications for the 2023 Volunteer Fire Assistance Grant (Grant) through ODNR Division of Forestry;

WHEREAS, the Jacksonville Volunteer Fire Department needs Personal Protective Equipment for structure fires, which qualifies for the Grant; and

WHEREAS, it is the Jacksonville Volunteer Fire Department's desire to apply for the Grant;

WHEREAS, if the Village is awarded the Grant, then the Village will be required to appropriate and expend \$3,700.00 from the Fire Fund for the purchase of the equipment, by separate Ordinance at a later date;

WHEREAS, if the Village of Jacksonville is awarded the Grant, and the Fire Chief will submit all items to Ohio Department of Natural Resources, Division of Forestry for reimbursement of \$1,850.00, which represents fifty percent of the total award.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO:


That the Fire Chief of the Village of Jacksonville is authorized by Village Council to prepare and submit an application to the Ohio Department of Natural Resources, Division of Forestry for 2023 Volunteer Fire Assistance Grant up to \$3,700.00. If awarded, the Fire Chief is authorized to execute the necessary agreements with Ohio Department of Natural Resources and submit purchases for fifty percent reimbursement in accordance with the grant agreement.
