

**RESOLUTION NO. 2023-9**

**A RESOLUTION AUTHORIZING THE FIRE CHIEF TO SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO BUREAU OF WORKERS COMPENSATION SAFETY INTERVENTION GRANT, EXECUTE ALL AGREEMENTS IF AWARDED AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Ohio Bureau of Workers Compensation (BWC) is accepting applications for the Safety Intervention Grant (SIG);

**WHEREAS**, it is the Jacksonville Volunteer Fire Department's desire to apply for the Grant to purchase equipment to substantially reduce or eliminate injuries and/or illnesses associated with the duties of the department; and

**WHEREAS**, if the Village is awarded the Grant, then the Village will be required to appropriate and expend up to \$40,000.00 from the Fire Fund for the purchase of the equipment by separate Ordinance at a later date;

**WHEREAS**, if the Village of Jacksonville is awarded the Grant, then the Fire Chief will submit all items to Ohio Bureau of Workers Compensation, for reimbursement of \$30,000.00, which represents the BWC "3-to-1 match";


**WHEREAS**, if the Village is awarded the Grant, then the Fire Chief will complete and submit the BWC one-year case study one year after the implementation date of the intervention as required by BWC;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO:**

That the Fire Chief of the Village of Jacksonville is authorized by Village Council to prepare and submit an application to Ohio Bureau of Workers Compensation, for the Safety Intervention Grant up to \$40,000.00. If awarded, the Fire Chief is authorized to execute the necessary agreements with Ohio Bureau of Workers Compensation and submit purchases for reimbursement in accordance with the grant agreement.
