

ORDINANCE NO. 2025-1

AN ORDINANCE AUTHORIZING AND ENTERING INTO CONTRACT WITH BATEMEN'S REFUSE FOR EXCLUSIVE TRASH SERVICES WITHIN THE VILLAGE OF JACKSONVILLE WITHOUT ADVERTISING FOR BIDS AND DECLARING AN EMERGENCY

WHEREAS, the Village of Jacksonville has been under contract with Bateman's Refuse ("Bateman's") since January 1, 2011 for Bateman's to be the exclusive franchise for trash collection services in the Village;

WHEREAS, the Village pays Bateman's an annual contract price of \$0.00;

WHEREAS, this amount is under the R.C. 9.17 threshold amount of \$75,000.00 and is not being increased by Bateman's at a percentage of three percent or more, therefore obviating the competitive bidding requirement;

WHEREAS, the Village receives exclusive trash collection's services and dumpsters from Bateman's and maintains control over the trash collection companies who travel and damage the Village roadways;

WHEREAS, Bateman's bills the customers directly with no assistance or input from the Village;

WHEREAS, Bateman's has decided, under its sole discretion as a company, to increase prices to the customers based upon increasing costs.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF JACKSONVILLE, ATHENS COUNTY, OHIO AS FOLLOWS:

Section 1: The Village of Jacksonville hereby authorizes the attached Contract for trash pickup with Bateman's Refuse Hauling Services, LLC.

Section 2: The Mayor is hereby authorized and instructed to execute the attached Contract for trash pickup with Bateman's Refuse Hauling Services, LLC.

Section 3: Competitive bidding is not required pursuant to O.R.C. 9.17 as the contract is at no cost for the Village of Jacksonville.

Section 4: This Ordinance is declared to be an emergency measure necessary to preserve the health, safety and welfare of the citizens of the Village of Jacksonville, Ohio and shall be effective upon passage or at the earliest date allowed by law.
