RESOLUTION 2025-12

A RESOLUTION AUTHORIZING A THEN & NOW PURCHASE ORDER TO JOHNSON'S EVS AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code 5705.41(D)(1) requires political subdivisions pass a resolution authorizing the issuance of a Then & Now purchase order in excess of three thousand dollars (\$3,000); and

WHEREAS, the Village of Jacksonville must issue a Then & Now purchase order to Johnson's EVS to issue payment for emergency repairs to Engine 1773 in excess of three thousand dollars (\$3,000); and

WHEREAS, the emergency repair to Engine 1773 was performed with no purchase order being issued out of necessity to place the Engine back in service to fulfill firefighting contract obligations; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Jacksonville, Athens County, Ohio, that:

<u>SECTION 1</u>: That Council hereby authorizes the Fiscal Officer to issue a Then & Now purchase order in the amount of \$5,000.00 in accordance with Ohio Revised Code 5705.41(D)(1).

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees on or after December 2, 1975, that resulted in formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

<u>SECTION 3</u>: This Resolution is declared to be an emergency measure necessary to preserve the health, safety and welfare of the citizens of the Village of Jacksonville, Ohio and shall be effective upon passage or at the earliest date allowed by law.
