Ordinance No. 2026-6

An ORDINANCE to make permanent appropriations for the current expenses and other expenditures of the Village of Jacksonville, Ohio, during the fiscal year ending December 31, 2026 and declaring an emergency.

Section 1. BE IT ORDAINED by the Council for the Village of Jacksonville, State of Ohio, that, to provide for the expenditures of the Village of Jacksonville during the year ending December 31, 2026, the following amounts be and they are hereby set aside and appropriated as follows:

Section 5. The Village Fiscal Officer is hereby authorized to draw warrants on the Village Treasury for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance; provided further that the appropriations for contingencies can only be expanded upon appeal by two-thirds vote of Council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by the other specific appropriations herein made.


