PURSUANT TO OHIO REVISED CODE SECTION 5705.03
(Dollar amount of revenue generated by specified number of mills)

WHEREAS, the Council of the Village of Jacksonville, Ohio, determines that it is necessary to levy a tax outside the ten-mill limitation, and

WHEREAS, before seeking to have a levy approved by the electors of the Village of Jacksonville the Council must seek the certification of the Athens County Auditor in compliance with Section 5705.03 of the Ohio Revised Code, submitted for the Primary election held on May 5, 2026

THEREFORE, BE IT RESOLVED, by the Council of the Village of Jacksonville Athens County, Ohio, that the Athens County Auditor is hereby requested to certify to the Council:

- 1. The total current tax valuation of the Village of Jacksonville, and
2. The dollar amount of revenue that would be generated by 3.20 mills.

BE IT FURTHER RESOLVED that the purpose of the tax is providing funds for General Fund - Current Operating Expenses within the Village of Jacksonville pursuant to 5705.19(A) Ohio Revised Code

And is for five (5) years, being first levied in tax year 2026, first collected in calendar year 2027 and appearing on the tax list for the years specified: 2026-2030

Such tax is authorized to be submitted to a vote of the electors of the the Village of Jacksonville pursuant to Section 5705.19(A) of the Ohio Revised Code, and shall be levied on the residents of the Village of Jacksonville pursuant to Section 5705.19(A) of the Ohio Revised Code and which shall be a renewal of an existing tax. List any other county into which this subdivision overlaps: N/A

BE IT FURTHER RESOLVED that the Athens County Auditor is requested to issue the certification within ten days after receiving this Resolution.
