RESOLUTION OF NECESSITY

*RESOLUTION REQUESTING CERTIFICATION FROM COUNTY AUDITOR
PURSUANT TO OHIO REVISED CODE SECTION 5705.03
(Dollar amount of revenue generated by specified number of mills)*

WHEREAS, the Council of the Village of Jacksonville, Athens County,
Governing body (e.g. board of trustees, etc) Political Subdivision
Ohio, determines that it is necessary to levy a tax outside the ten-mill limitation, and

WHEREAS, before seeking to have a levy approved by the electors of the Village of Jacksonville,
Portion of Political Subdivision (authorized to vote on issue)
the Council must seek the certification of the Athens County Auditor in compliance with Section
Governing Body
5705.03 of the Ohio Revised Code, submitted for the General election held on November 3, 2026,
General, Primary, Special Date of Election

THEREFORE, BE IT RESOLVED, by the Council of the Village of Jacksonville,
Governing Body Political Subdivision
Athens County, Ohio, that the Athens County Auditor is hereby requested to certify to the Council,
Governing Body

1. The total current tax valuation of the Village of Jacksonville, and
Portion of Political Subdivision (authorized to vote on issue)
2. The dollar amount of revenue that would be generated by 5.00 mills.

BE IT FURTHER RESOLVED that the purpose of the tax is providing fund for Fire Protection Services within
the Village of Jacksonville pursuant to section 5705.19(I) Ohio Revised Code

And is for five (5) years, being first levied in tax year 2027, first collected in calendar year 2028,
Number of years or continuing period of time (CPT)
and appearing on the tax list for the years specified: 2027-2031.

Such tax is authorized to be submitted to a vote of the electors of the the Village of Jacksonville pursuant
Portion of Political Subdivision (authorized to vote on issue)
to Section 5705.19(I) of the Ohio Revised Code, and shall be levied on the residents of the

Village of Jacksonville pursuant to Section 5705.19(I) of the Ohio Revised Code and
Portion of Political Subdivision (upon which tax will be levied) ORC Section
which shall be a renewal of an existing tax. List any other county into
(Describe the levy, such as: an additional levy, a renewal of an existing tax, a replacement of an existing tax, etc.)
which this subdivision overlaps: N/A

BE IT FURTHER RESOLVED that the Athens County Auditor is requested to issue the certification within ten days
after receiving this Resolution.
