**WHEREAS**, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the said Village of Jacksonville,

Athens County; therefore be it

**RESOLVED**, by the Council, Athens County, two-thirds of all members elected  
Governing body  
thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the  
Village of Jacksonville for the purpose of General Fund - Current Operating Expenses of  
Political subdivision Purpose (use additional lines if needed)  
the Village of Jacksonville pursuant to section 5705.19(A) Ohio Revised Code

that the county auditor estimates will collect \$ 18,956 annually, at a rate not exceeding  
Amount of revenue from auditor's certificate  
5.30 mills for each \$1 of taxable value, which amounts to \$ \$ 144.000 for each  
Millage Rate expressed in dollars  
\$100,000 of the county auditor's appraised value, for five (5) years commencing in 2027,
